





Drivers of Change

- International organizations and regulatory authorities
- Technological developments
- Heightened consumer awareness
- E-commerce
- Climate change







Drivers of Increased Enforcement

- Increasing number of specialist regulators
- Greater institutionalised cooperation between regulators
- Recruitment of consumers as enforcers
- Changing perceptions of safety









Key Initiatives in EU & UK Product Regulation

Continued Focus on Regulating New Technologies

Recent Examples Include:

Cyber Resilience Act

Aims to ensure that products placed on the EU market have fewer vulnerabilities **throughout their lifecycle**.

Enhances cybersecurity requirements and standards for products with **digital elements**.

Applies to both **hardware** and **software** products that connect to other devices or networks.

Introduces design and development obligations for manufacturers, importers, and distributors.

AI Act

Aims to ensure that Al is developed and deployed in an **ethical** manner.

Risk-based, with some Al systems **prohibited** and different obligations for **high-risk**, **limited-risk**, and **minimal-risk** Al systems.

Prohibited Al systems include those which manipulate behaviour or use certain biometric categorisation.

Most stringent regulatory requirements for highrisk Al systems, including including **technical documentation**, **cybersecurity measures**, and **incident reporting**.





Continued Focus on Regulating New Technologies

Reforms Targeting New Technologies Also Have Broader Impact

General Product Safety Regulation (GPSR)

Seeks to modernize product safety rules in response to **digital** and **global market changes**.

Applies to all non-food consumer products, including **connected** and **Al-enabled devices**. Commission taking position that standalone software is in scope.

New **labelling** and **website** requirements

Requires a **Responsible Person** for products sold in the EU to ensure compliance.

Introduces accident reporting, new recall obligations, and stricter market surveillance.



Product Liability Directive (PLD)

Expanded scope – not just hardware, but also software, Al systems and related services.

More damages – including data loss/corruption and medically-recognised harm to psychological health

Expands liability to **online marketplaces**, **fulfilment service providers**, and those **modifying** products.

Makes it easier for consumers to claim compensation by introducing presumption of defect in some circumstances – including where relevant regulatory non-compliance

Introduces new disclosure/discovery obligations into EU, which are new in many member states.



Sustainability and the Right to Repair

From Design, to Point of Sale, and Beyond

Ecodesign for Sustainable Products Regulation (ESPR)

Requirements to design for repairability and for spare parts.

Requires information on **how to repair** & **Digital Product Passports** (DPPs).

Batteries Regulation

Requirements for appliances to be designed for batteries to be readily **removable** and **replaceable** by endusers.

New supply chain, due diligence and reporting requirements

ECGT & Green Claims Directive

Consumer information requirements related to **repairability**, **spare parts** and **software updates**.

Energy labelling requirements

Product-specific (e.g., mobile phones, tablets).

Includes a **repairability score** on the label, and requirements to include **information on repairability** in Product Information Sheet.

Right to Repair Directive

Amends statutory warranty under the Sale of Goods Directive to **encourage repair**.

Establishes new obligation on **manufacturers to repair** (outside of statutory warranty) certain goods

Includes new mechanisms to facilitate repairs.





Digitalization of Compliance Enforcement

Digital Product Passports (DPPs)
 Digital records of the physical product's lifecycle, including manufacturing details, materials, and environmental impact.

Customs reform

Overhaul of customs procedures the introduction of a "Trust and Check" trader status, data hubs for e-commerce and other businesses, and a new focus on compliance with EU product standards.







UK Divergence

New Laws Providing for Flexibility and Adaptation to the UK Market and Regulatory Environment

- Product Regulation and Metrology Bill
 Update to UK's post-Brexit product safety and regulation framework. An enabling act with broad powers for the UK to align with / diverge from the EU.
- Digital Markets, Competition and Consumers Act 2024 Introduces a new regulatory regime for large digital market platforms. Significantly widens enforcement remit of CMA in consumer protection, particularly in relation to online activities.



EUDR

and Recent Guidance

- From December 31, 2025 the EUDR prohibits the import, export or the making available on the EU market certain commodities and derived products linked to deforestation
- Goods must be:
 - Deforestation-free
 - Legally produced
 - Accompanied by a due diligence statement (DDS)
- **DDS** must be filed <u>before</u> the product can be made available on the EU market, imported or exported and must contain, e.g., geolocation coordinates of production site
- Recent Commission guidance has aimed to clarify and simplify obligations, particularly for downstream traders







ESPR


Repeals and Replaces the Ecodesign Directive 2009/125/EC

- Expands scope of ecodesign requirements beyond energy-related products to all physical products (including components and intermediate products such as steel and aluminium) placed on the EU market with few exceptions, e.g. vehicles, food, medicinal products
- Delegated legislation will set out mandatory ecodesign requirements for specific product categories. High priority product groups set out in first working plan included energy-related products and new product groups:

2026: Iron & Steel

2027: Textiles/Apparel, Tyres, Aluminium

2028: Furniture2029: Mattresses








ESPR

Delegated acts for each product group will set out **design and performance requirements** and **information requirements**including details on what to include in the Digital Product Passport

- Performance requirements may relate to, e.g.:
 - Durability, repairability
 - Presence of "substances of concern"
 - Energy use and efficiency
 - Water use and efficiency
 - Recycled content
 - Recyclability
 - Product carbon footprint
- Information requirements may relate to, e.g.:
 - Information on performance of the product, e.g., a repairability score, a durability score, an environmental footprint score
 - Information on how to install, use, maintain and repair the product
 - Information on disposal







ESPR



New annual disclosure
obligation on number and weight
of unsold consumer products
discarded per year



First filing in 2026 on FY2025 data



Ban on destruction of unsold consumer products (currently limited to footwear, apparel and clothing)





product groups









PPWR

Repeals and replaces the Packaging and Packaging Waste Directive (94/62/EC)

- As a "Regulation" this law will apply directly in each EU Member
 State providing for greater harmonisation
- The PPWR will introduce:
 - New sustainability requirements
 - New compliance and producer responsibility requirements
 - New labelling requirements
 - New requirements for green claims

August 12, 2026

August 12, 2028

January 1, 2030

Requirements on:

- "Substances of concern"
- Traceability labelling


Requirements on:

- Pictograms requirements
- Harmonised labelling

Requirements on:

- Recycled content
- Recyclability
- Packaging minimisation, etc.





Supply Chain Transparency & Responsibility

Several recent EU laws focus on supply chain transparency and due diligence, promoting sustainability, responsible business practices.



Batteries Regulation

Supply chain diligence and producer responsibility obligations apply from **August 18, 2025**



Deforestation Regulation

Supply chain diligence obligations for listed products and commodities apply from **December 30**, 2025



Packaging and Packaging Waste Regulation

Sustainability requirements and EPR obligations apply from **August 12, 2026**

(UK EPR equivalent already applies (as of January 1, 2025))



Forced Labour Regulation

Prohibition applies from December 14, 2027 with risk of investigation and enforcement creating pressure to conduct upstream due diligence





EU Omnibus Legislation

Initiated Under New Commission to Reduce the Regulatory Burden

Key texts covered by the Omnibus:

- CSRD: Corporate Sustainability Reporting Directive
- EU Taxonomy Regulation
- CSDDD: Corporate Sustainability Due Diligence Directive

Content of the future Omnibuses

- Introduction of a "small mid-cap" category of companies
- Digitisation to remove inefficient paper formats in product legislation
